Frequently Asked Questions

1-Can I submit my application in English?

No. applications are to be submitted in Arabic only.

2-Are non-Arab applicants eligible to submit applications?

Yes, applicants holding non-Arab nationality are eligible to submit a request for fund. However, the project must be targeting Arab audience in the Arab region.

3-Does AFAC support cultural/artistic/literature projects outside the Arab region?

Venue of sponsored projects should be the Arab Region, and the targeted audience should be the Arab audience in the Arab Region.

4-What is the Maximum limit and Minimum limit for the grants?

There are no limits for the grants supported by AFAC. Applications will be assessed by a specialized panel that will develop an estimate of the amount that should be granted for the project.

5-Does AFAC support scholarships?

No. AFAC does not support scholarships even if they were among the areas they support.

6-Does AFAC support projects 100%?

The Jury can recommend any portion of grant based on their assessment of the project.

7-Does AFAC support projects of translating Arab literature into other languages?

No. AFAC does not support this kind of projects. Since AFAC main goal is to support the projects that are addressed to Arab audience in the Arab region.

8-Should the applicant have previous completed work?

No. It is not necessary to have previous work.

9-Can the applicants apply for a grant to establish a website specialized in cultural issues and literature?

Yes, such projects are acceptable.

10-Does AFAC support film production and movie scripts writing?

Yes. AFAC supports this kind of projects.

11-Does AFAC support workshops related to arts and culture?

Yes. AFAC supports workshops related to arts and culture.

12-Are Call of Proposals available any time of the year?

Calls of proposal are released in a specific time set by AFAC. It starts this year, on May 2008 and ends on September same year.

13-Can the applicants apply to get fund for more than one project?

Yes they can. However, they have to apply two separate applications for each project.

14-What is the annual report you ask for in the application form for organizations?

The annual report is a document that shed light on the activities and achievements that the institutions make during the past year. It is a mandatory requirement for organizations applications.

15-Can the applicants provide previous work samples via email?

Yes they can. However, they need to pay attention to the size of the sample. If the size is more than 2 Mega Byte, we prefer you send it by regular mail to our postal address shown in the bottom of the application form.

16-Would AFAC consider previous applications presented in (2007) for the 2008 round?

No. AFAC will not consider previous applications. Applicants must submit new applications.

17-Is it acceptable to apply for AFAC grants without enclosing samples of previous work?

Applications with no sample will be disregarded. However, applicants with no previous completed work should include samples of their current work, for example, drafts of the novel to be published.

18-Will AFAC be informing the applicants that their applications have been received?

AFAC Team will send immediate confirmation of receipt to applicants. If the applicant did not get such an email, then his/her application was not received by AFAC.

19-Is it necessary to send the original application by regular mail in addition to sending it by email?

No. sending an application by email is enough. Also, if the applicant prefers to send the application to our postal address, no need to resend it by email.
